Conductors on the pool freight board will work first-in first-out among themselves, out of Winslow, Arizona, subject to the provisions of this agreement.

- 1. Foot of the Board (FOB)
 - a. Conductors may at anytime before they reach 6 times off the active or working board, request that crew management move their turn to the FOB.
 - (1). Conductors can make this request only once during a layover, and only twice during a semi-monthly payroll period.
- 2. Conductors cannot make a FOB move within 5 days of the following National Holidays:
 - Christmas Eve and Christmas
 - New Year's Eve and New Years
 - 4th of July
 - Thanksgiving

3. Either party may cancel this agreement by serving a written notice 24 hours before cancellation, one party upon the other.
