MEMORANDUM OF AGREEMENT Between: The Burlington Northern and Santa Fe Railway, and The United Transportation Union, (C, T, & Y) (Coast Lines), representing Employees in Calwa Yard, Fresno California.

The purpose of this agreement is to establish an Independent Herder position in Calwa Yard, Fresno California, that can perform all the duties of a regular herder, as well as assist inbound and outbound freight crews.

The rate of pay for Independent Herder positions, established at Calwa Yard, will be \$182.36, per 8 hour shift.

The independent herder may be required to:

- 1. Herd power, including making air hose couplings between the consist and train, and also MUing the consist.
- 2. Assist in making pick-ups, including set and release of hand brakes, making couplings, and relaying and/or giving instructions via hand and/or radio signals.
- 3. Assist in making set-outs, including bad order cars, spotting cars, securing cars, and relaying and/or giving instructions via hand and/or radio signals.
- 4. Line main track and yard switches within working limits.
- 5. Make air hose couplings between cars and assist in, or perform, initial terminal inspection and air test.

When assisting a road crew, the independent herder will become a member of that crew.

When an independent herder assists a Conductor in performing service defined by Article II (2) of the 1992 Memorandum of Agreement, as a work event, the service performed will still be a work event for the Conductor.

This agreement will become effective on, Sanvary 11, 1999.

This agreement is subject to automatic cancellation by the service of 10 days notice one party upon the other.

A. The West limit is the AMTRAK Depot, MP 998.1 The East limit is THORPE, MP, 993.

- 2. Q. May Independent Herders be required to bless cuts of cars when they are not assisting a road grew?
 - A Yes
- 3. Q. If the independent Herder is required to handle an ETD or couple of loses when assisting a road ground crew, will the sligible members of the road ground crew receive ETD or air pay, (code 34, and 13), as appropriate?
 A. Yes
- 4. Q. Will the Independent Herder be required to perform Dog Catch service?

 A. No.
- 5. Q. Will the Independent Herder be required to assist yard crows? A No.
- 6. Q. Will the Independent Harder be subject to all other yard agreements and contractual provisions, as set first in the yardmen's schedule?

 A. Yes.
